## Patricia A. Redmond Receives The Florida Bar's 2019 Tobias Simon Pro Bono Service Award

Through clinical programs, mentoring students for an average of 10 pro bono matters annually, and taking on pro bono cases of her own, Trish devotes approximately 200 to 400 hours each year to pro bono work benefiting thousands of underprivileged and low-income individuals, children and families. She also mentors colleagues, new pro bono attorneys and others in need of advice and guidance year round.
