- Permitted **essential and additional services, and amenities (professional and personal services, restaurants and food establishments, retail establishments, movie theaters, community amenities, and public/private pools)** must comply with specific guidance.

- All **parks** open to public on limited basis for passive uses with social distancing guidelines.

- **Golf courses** may open on limited basis with golf-specific social distancing guidelines.
- **Pools and other residential amenities** must remain closed, unless: (1) required to remain open to conduct essential service; (2) located on a single family residential lot, a single townhouse unit, or any part of a duplex lot, so long as used only by the residents of the home; or (3) pools in multifamily housing developments, condominium developments, single-family homeowner associations provided the pools are used only by current residents, social distancing guidelines are adhered to, and occupancy is limited to 50%.
- All **beaches** remain closed.
- All **workers involved in food preparation** must wear facial coverings.

April 10, 2020 – Emergency Order 20-07 (AMENDED)

- All persons providing essential service must **wear facial covering** during in-person interactions.
- Members of the public must **wear facial covering** when obtaining essential services.
 - Exemptions include: children under 2; persons with difficulty breathing; and public safety, fire, or other life safety personnel.

April 9, 2020 – Emergency Order 20-06 (AMENDED)

- All **nonessential non-profit, retail, and commercial establishments** to close.
- All **essential businesses** strongly encouraged to provide hand sanitizer, provide disinfecting wipes at entrances, and have sanitizing checkpoints for custodial staff.
- **Nonessential services** can perform minimum basic operations provided such entities practice social distancing and other measures advised by the CDC.
- **Religious services** not prohibited. All persons performing or attending urged to comply with CDC guidelines, including social distancing and limiting gatherings to under 10.

April 3, 2020 – Emergency Order 20-05 (AMENDED)

- All **essential services** are to use reasonable efforts to maintain social distancing.
