

Stearns Weaver Miller Tallahassee Lawyers Recognized in *The Best Lawyers in America* 2023

Tallahassee, FL — August 19, 2022 — Stearns Weaver Miller announced that 13 Tallahassee lawyers were recognized in the 2023 edition of *The Best Lawyers in America*, eight of whom were recognized for the first time this year.
