Stearns Weaver Miller honored with 2020 Tallahassee Women Lawyers Diversity & Inclusion Leadership Award

Tallahassee, FL – June 11, 2020 – Stearns Weaver Miller is honored to be selected as the recipient for the 2020 Tallahassee Women Lawyers Diversity & Inclusion Leadership Award. Tallahassee Women Lawyers (TWL), an affiliate of Florida Association for Women Lawyers (FAWL), is an organization that provides leadership, a collective voice, and essential resources to advance women in the legal profession and advocates for the equality of women under the law.

The award recognizes those who display a leadership role in promoting diversity and inclusion within the workplace and/or community. It measures both the intensity of commitment and level of achievement of inclusion initiatives such as: recruitment and retention efforts, research, multi-cultural programming, cultural competency, and community outreach activities. Through this award, TWL aims to "shine a light on good practices in our community and to inspire others to replicate successful initiatives."

Attorney Melanie Leitman is an active member, and attorney Jessica Icerman served on the Executive Board from 2017-2020.
