you know, and we also face many challenges. Today, I believe we are blessed with tremendous opportunities to continue positive growth and change, and propel our desire to confront these challenges. We must continue to improve our community. In many instances we can turn challenges into opportunities. This is not only the heart of the Leadership Tallahassee program, but also the Chamber. The Chamber represents 1,400 members comprised of over 50,000 employees. As such, the Chamber is the leading business organization in the Capital region.

As you've probably noticed in recent months there have been many changes at the Chamber. These changes are reflective of the Chamber adapting and planning for the future. The recent dissolution of the Economic Development Council (originally birthed by the Chamber) and the Blueprint 2000 Intergovernmental Agency's assumption of the role as the economic development agency reflects the evolved outcome of the November 4, 2014 decision of 65% of Leon County voters who overwhelmingly approved a 20-year extension of the sales tax, which included 12% (estimated at \$90.7 million) set aside to support economic development projects, programs, and initiatives. We are only one of two communities in Florida to take advantage of this opportunity. While this has been a dominating focus, I would encourage each of you to consider the other 88% (estimated at \$660+ million) of these dollars which will be dedicated to major infrastructure projects throughout Leon County. The economic impact will be substantial. Your Chamber was forward-thinking years ago in supporting this outcome. This support was critical to the success of this economic opportunity.

These recent changes have not been without debate. Leadership is not designed to be easy, and at times requires difficult decisions in the face of evolving, dynamic circumstances. We know from experience that everyone will not agree. Your Chamber Board has worked hard to embrace change, debate the possibilities, and make the difficult decisions. I'm proud of our Chamber Board for their hard work and caring about the future of our members and this community.

As most of the dust settles from recent decision-making, the Chamber is looking ahead to the opportunities that lie in the wake of these changes. This will require that we continue to adapt and change as an organization.

Timbers hosted the group and the Class developed a greater understanding and appreciation for our ecological assets and their importance in maintaining a high quality of life in Leon County and the Red Hills. They also realized they did not know much about wildlife and native plant species as Tall Timbers staff tested their Nature IQ and **Lane Green (LT 5)** set the stage for the afternoon's activities highlighting "Smokey Bear Got

it Wrong"! The Red Hills Farming movement was featured as another "unique to Tallahassee" sector and after lunch provided by Tall Timbers and Tharpe Construction, the crew headed to the great outdoors.
