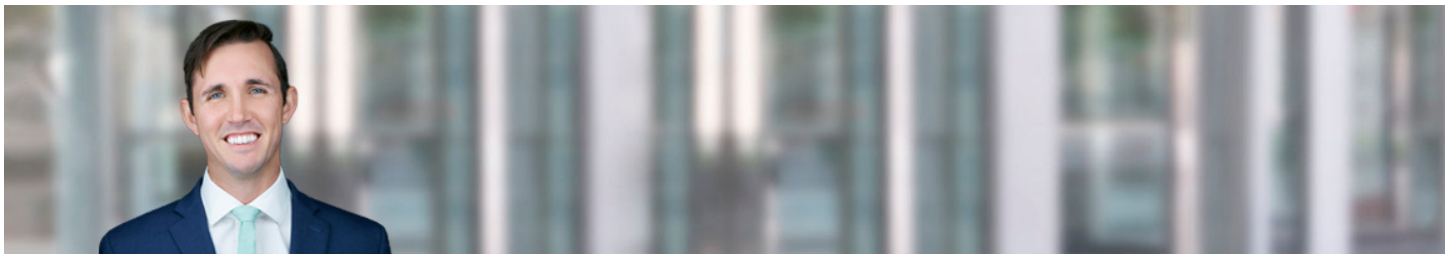

### OVERVIEW

Christopher Clark is an Associate in the Litigation Department.
