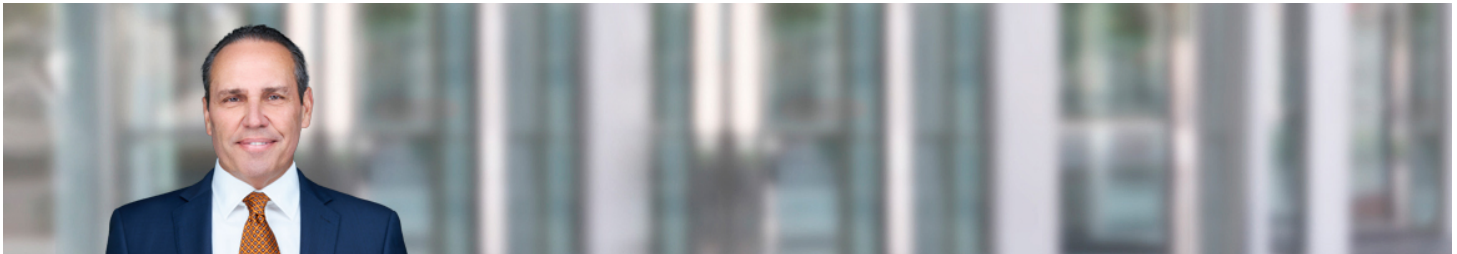

### OVERVIEW

Francisco "Frank" J. Menendez is a Shareholder in the Real Estate Department. ### REPRESENTATIVE EXPERIENCE

Represented the owners of 89 hotel properties located in 16 states and in Canada in connection with a \$265,000,000 loan to refinance the properties and provide working capital therefor.
