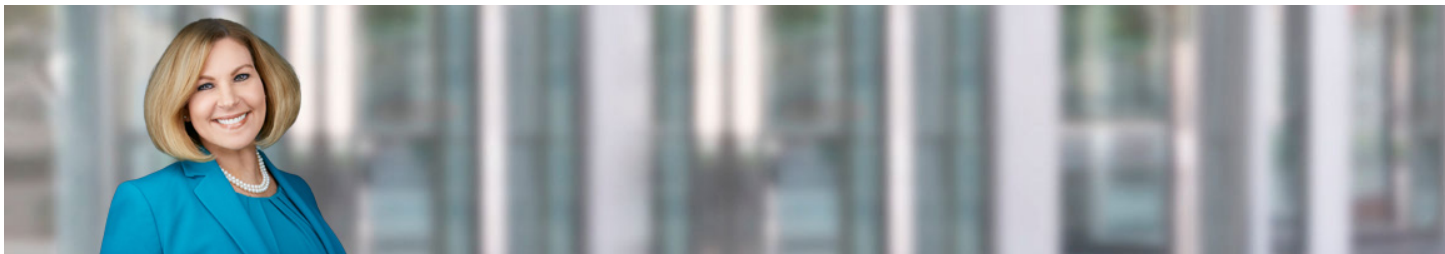

OVERVIEW

Gigi Rollini is an experienced litigator and Shareholder in our Tallahassee office, and leads the Firm's Government and Administrative Practice Group. Her practice encompasses administrative and civil litigation and appeals, and all aspects of Florida administrative law, including regulatory compliance, licensure, administrative complaints and disciplinary proceedings, government contracts, procurement and bid protests, rulemaking and rule challenges, state and local taxation, election compliance and litigation, and non-profit and trade association formation, compliance and management.

Gigi has been named one of Florida's "Top 50 Women Lawyers" by Super Lawyers magazine, an "Extraordinary Woman" by the Florida Association for Women Lawyers (FAWL), the Panhandle's "Woman of Distinction" in Law by the Girl Scout Council, and one of Tallahassee's "25 Women to Know" by the Tallahassee Democrat. She has earned Martindale's highest AV-Preeminent Peer Rating in appellate, administrative and civil litigation, and is regularly recognized by Florida *Super Lawyers* and *Florida Trend* magazines in appellate and administrative law. She serves on The Florida Bar's Administrative Law Section Executive Council, and is a past chair of the Appellate Court Rules Committee's administrative and civil appeals committees.

Gigi serves as an Executive Officer of the National Association of Women Lawyers (NAWL), after serving many years as Florida's delegate to NAWL and on the board as a member-at-large. Gigi previously served as president of the Tallahassee Women Lawyers, and as president of FAWL—only the fifth woman from Tallahassee to serve in that capacity since FAWL's inception in 1951.

Prior to entering private practice, Gigi was senior judicial clerk to Judge Robert T. Benton II at Florida's First District Court of Appeal. While in law school, Gigi received a Florida Bar Foundation Public Service Fellowship to work in the Office of the State Attorney (2nd Jud. Circuit), focused on felony cases involving children and women victims. Gigi was a judicial intern for The Honorable Robert L. Hinkle at the U.S. District Court for the Northern District of Florida.
