### OVERVIEW

## REPRESENTATIVE EXPERIENCE

Experience utilizing 3-D technology for analysis and visualization including building variances within height restriction zones, comparison of surrounding building heights with proposed construction to illustrate conformance with existing structures, analysis of sun angle and the effects of shadows throughout the day and year, and land use restrictions based on airport flight paths. These illustrations and analysis have been a valuable component in plan amendments, infrastructure approval, and addressing objections to proposed developments.

### Other Industry Experience

At the Northwest Florida Water Management District (NFWFMD), Shawn served as a liaison between the GIS Team and each Division of the NFWFMD. Shawn was tasked with employing GIS solutions across the organization that would

help increase staff efficiency and improve data accountability. Shawn developed and maintained a multi-user land management database consisting of over 40 feature types and thousands of physical assets maintained on NFWFMD lands. Shawn also was responsible for development of a project management GIS database for tracking and monitoring project progress and budgets, and developed operations dashboards for communicating progress and budgets with NFWFMD management.

While employed at the Northwest Florida Water Management District (NFWFMD), Shawn worked with Hydrologic and Hydraulic models and their GIS outputs to identify homes and buildings with increased risk of riverine flooding as a result of in-channel and floodplain debris resulting from Hurricane Michael. Shawn's work helped the NFWFMD prioritize river and stream segments for debris removal.
