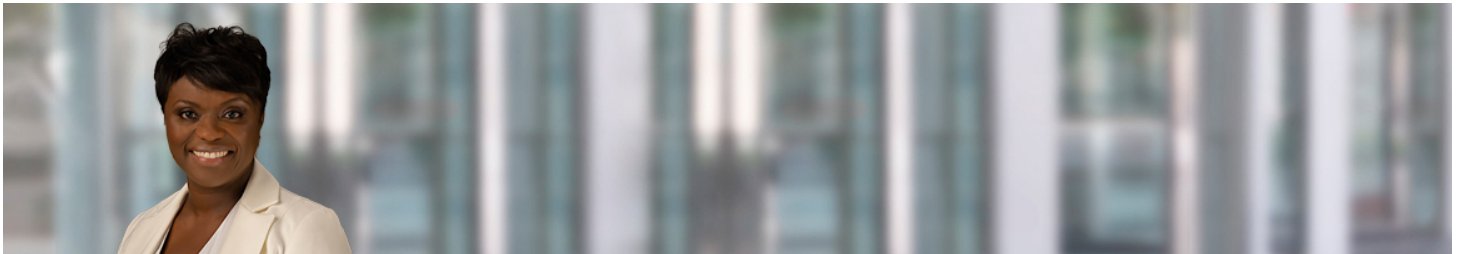

OVERVIEW

Vinette Godelia is a skilled negotiator and highly-regarded litigator in the Land Development, Zoning & Environmental arena. She represents private and public sector clients before local, regional and state agencies, courts and elected bodies regarding land use and real estate development issues.

Vinette focuses her practice on the defense and negotiation of complex approvals under Florida's growth management laws and local government regulations. She leads, coordinates and oversees legal and expert consultant teams on complex planning issues throughout the state. She is also experienced in challenging, securing and defending development entitlements in formal hearings before the Division of Administrative Hearings and circuit and appellate courts.

Vinette counsels clients in a wide-range of matters involving entitlements, permitting, compliance, licensing, rezonings, special districts, Development of Regional Impact (DRIs) review and rescission, comprehensive planning, zoning and strategic planning as well as development agreements. She is experienced in developing strategic and targeted revisions to comprehensive plans and land development regulations to facilitate site-specific project development and the negotiation of local development order terms.

Vinette is skilled in understanding complex land use intricacies in relation to residential, commercial and mixed-use communities, as well as for industrial facilities including mines and oil and gas exploration and production companies.

Before her legal career, she worked with Visit Florida, the state's official tourism organization, in various capacities including public relations and destination sales. REPRESENTATIVE EXPERIENCE

Represents Mosaic, the world's leading integrated producer of concentrated phosphate and potash, in permitting issues for their mine operations including work on over 50,000 acres in Manatee, DeSoto, Polk and Hardee Counties. Representation includes large area approvals, DRI rescissions, creation of comprehensive plan mining overlays, special exceptions, master plans and other development orders and resource impact approvals.

Routinely negotiates with local regional and state agencies on approvals for oil and gas exploration and production in Calhoun, Santa Rosa and Gulf counties within the state of Florida.

Represented the New Wales, Bartow Chemical Plant and Green Bay facilities in developing the regulatory and public involvement strategy for DRI exemptions and local government review of gypsum stack expansions in Polk County, Florida. The entitlements were supported by negotiations with the Department of Economic Opportunity and Department of Environmental Protection on mitigation of impacts involving significant monitoring requirements.

Represented Duke Energy with the development process for a new Combined Cycle Power Plant. The matter involved procuring land use entitlements including comprehensive plan amendments and rezoning approvals for a 1,640-megawatt combined cycle natural gas plant in Citrus County.

Represented Duke Energy in amending the Hamilton County Comprehensive Plan and the Hamilton County Land Development Code to allow the establishment of solar generating facilities in rural areas. The proposed amendments add solar electrical generating facilities as a permitted activity, governed by special permit. The companion land development code amendment add definitional components and performance standards for purposes of providing objective criteria for evaluating and siting a request for a special permit to locate such facilities.

Represented Seminole Electric in the development process for a new Combined Cycle Power Plant. The matter involved procuring land use entitlements including comprehensive plan amendments and rezoning approvals for a 1,130-megawatt plant in Putnam County.

Represented client in the reworking of historic entitlements for a mixed use project located off Florida Interstate 4 in Polk County, Florida. The matter required the negotiation of significant changes to the regulatory scheme applicable to the project including the removal of development of regional impact restrictions through novel interpretations of state and local law, approval of new comprehensive plan and code amendments, negotiation of infrastructure related development agreements and other related issues.

Represented developer and conducted due diligence review before the City of Tallahassee and other community groups to allow the purchase and development of student focused multi-family housing development in a historic African-American community. The project was met with significant public opposition and required negotiation of terms that the neighborhood could find acceptable to incorporate design elements and uses supportive of the history of the area and the neighborhood.
