

INVESTITURE CEREMONY OF JUSTICE RENATHA FRANCIS



LASHAWN RIGGANS HONORED WITH ROSE DEEB KITCHEN AWARD

Not all law careers are built on a straight and linear path. Instead, some of the most remarkable legal careers are built on the ability to rise to the challenges of life, and a willingness to adjust the path in pursuit of a larger purpose and calling. Rose Deeb Kitchen became an attorney despite many obstacles, including a culture that did not prioritize the education of women, a divorce, and raising three children as a single parent. This award women who recognizes overcome obstacles and hardship to become attorneys.

LaShawn Riggans has demonstrated through her career and service to the community what it means to be resilient. Ms. Riggans grew up in Grand Rapids, Michigan, living with her mother during the school year, and with her father in Chicago during the summers. Her family's financial resources growing up were sometimes limited, but her mother was a great example to her of making the best of challenging situations.

After graduating from high school and attending some junior college classes, she made a life altering-decision to forge a new path for herself by joining the U.S. Navy. In the Navy, she held a high security clearance and worked on intelligence collection. She was stationed in the Republic of Panama and Okinawa, Japan. The birth of her daughter while overseas led her to the difficult decision of leaving the military, putting her career on a new trajectory.

Ms. Riggans went on to pursue a Masters Degree in Public Administration at Kennesaw State University. During this time, she worked as a victim advocate in the Cobb County Attorney's Office. This experience informed her decision to pursue a career in law. Though she connected with the individuals she assisted navigating the legal system, she knew she could be of greater service as a prosecuting attorney.

Despite challenges in her personal life at the time, including raising a child and going through a divorce, Ms. Riggans successfully pursued her Juris Doctor and was admitted to the Florida Bar.

Ms. Riggans has spent the majority of her legal career in public service, having worked first as an assistant state attorney for the Florida First Judicial Circuit, in Shalimar, Florida. During this time, Ms. Riggans also taught as an adjunct professor for the University of West Florida. Ms. Riggans then worked as an Assistant County the Attorney in Leon County Attorney's Office, before she was promoted to Deputy County Attorney, where she served until 2023. She is now of counsel with Nabors, Giblin, & Nickerson, P.A., and continues to dedicate her practice local government issues.

Outside of work, Ms. Riggans focuses on service to the legal community and her community at large. This includes volunteer speaking engagements, mentoring **FSU** law students, involvement with various charitable organizations, and service to voluntary bar organizations. Ms. Riggans is currently appointed to the Florida Bar Professional Ethics Committee and has volunteered with Leon County

Teen Court, Leon County Classroom to Courtroom, Natural Disaster Animal Sheltering, and Nims Middle School Civics. Ms. Riggans is also an ordained pastor and stays involved with the community through outreach ministry through Heaven 2 Earth Ministries. She also works as a life coach. Ms. Riggans was recognized in 2019 by the Tallahassee Democrat as one of the "25 Women You Need to Know."

NOVEMBER CLE LUNCH & LEARN: END OF YEAR GIVING

November, 9, 2023, TWL hosted a Lunch and Learn with attorneys Katrina Rolle, President and CEO of the Community Foundation of North Florida, Mary Lalley Wakeman, Partner at Heuler, Wakeman, Solomon Law Group, and Florida State University's College of Law student Jennifer Camisa. The event was centered around charitable giving and estate planning.

Katrina Rolle is the President and CEO of one of the region's leading philanthropic organizations. Community Foundation of North Florida 's mission is to enhance the quality of life in North Florida community by connecting donors to charitable causes which they care most to support.

Mary Wakeman is partner at a Tallahassee Elder Law Firm, Hueler, Wakeman, Solomon Law Group, PLLC. Wakeman practices in Elder Law and Civil Appeals. Talking about estate planning, she reflected:

"When most people hear the word 'estate planning' they think to themselves 'but I have no estate to leave anyone.' If you own a car, have a bank account and/or own property, then you have assets that will form the basis of your estate at your death. Estate planning through a will or a trust allows you to determine who or what entity you want those assets to go to when you are deceased. Many people also overlook the importance of Advance Directives like a Durable Power of Attorney, Living Will, Designation of Health Care Surrogate and Declaration of Preneed Guardian. These are all documents used during your lifetime that allow someone else to handle your finances and make health care decision for you if you become unable to make them yourself. Putting all these documents in place will ensure that whatever events may befall you during your lifetime, you are well prepared for them."

A PRIMER ON PIXELS: THE LEGAL RISKS OF WEBSITE ANALYTICS

We've all had that online experience where you've searched and browsed for a product, and then been steadily bombarded with ads for that product, or by the companies whose websites you visited. And while those ads might be helpful (or creepy) to consumers, companies using online tracking technologies may be exposing themselves to significant legal risk of violating state and federal privacy laws. The latest risk involves a "pixel," which sounds cute and non-threatening, but is the darling of the plaintiff class action bar, and the focus of state and federal privacy law enforcers.

So what is a pixel? A pixel is a piece of code that can be placed on websites to facilitate the tracking of user actions on those sites, helping companies to assess the effectiveness of their advertising campaigns and how visitors use the companies' websites. Meta Pixel (formerly known as Facebook Pixel) is a commonly used tool provided by Meta Platforms, Inc. (formerly Facebook), but many other companies provide similar tracking technologies, including Microsoft Clarity, Google Analytics, and Adobe Analytics, among others. For convenience, we will refer to the fictional company Acme Corporation ("Acme") as using the Meta Pixel on its website, and placing targeted ads on websites their audiences visit.

What does Meta Pixel actually do, and how does it help companies that use it? As visitors click around and interact with various pages on Acme's website, those actions will be recorded and transmitted to Meta, which collects the data and then provides reports to Acme of all the user activity on the Acme website where the pixel code has been embedded. Key functionalities and features of Meta Pixel include:

- Conversion Tracking: tracks user actions after they click on Acme's ad on Facebook, such as purchases or form submissions.
- Custom Audiences: Enables the creation of tailored audience groups based on user actions for more personalized advertising such as targeting people aged 25-45, who liked "hiking," "kayaking," or "golden retrievers" on Facebook with Acme SUV ads.
- Remarketing: Facilitates targeted ad displays to users who visited the Acme website but did not complete desired actions (for example, the user put an item in a shopping cart but did not complete the transaction).
- Insights and Analytics: Provides valuable data on website user behavior for optimizing ad campaigns and enhancing website performance.
- Dynamic Ads: Allows advertisers to create automated, dynamic ads based on user interactions with the website.

That data, and those reports, can help companies like Acme send targeted ads to those who browsed their websites, and may also be sold by Meta to third parties to use for marketing or other purposes. That sharing and use of browsing activities is why you may see digital ads for Acme products after browsing Acme.com, or clicking on some Acme page or ad on Facebook.

The feeling of being watched or surveilled can be upsetting to some, particularly if the information collected is of a sensitive nature.

Companies that use pixel technology must be aware of the various laws that might apply to their collection of data, and equally important, the sharing of that data with third parties such as Meta. Determining what laws apply will depend on a variety of factors, including the kind of data collected, in what jurisdictions the company and whether operates, the company's advertisements target people in certain states or countries. For example, healthcare providers subject to HIPAA or state healthcare privacy laws must ensure that protected health information (PHI) of website users is not collected by pixels and transmitted to third parties unless those third parties are subject to a business associate agreement under HIPAA. In case you were wondering, Meta/Facebook does not enter into business associate agreements with companies using the Meta Pixel.

Accordingly, the use of tracking tools like Meta Pixel comes with legal risks, as evidenced by a variety of recent class action lawsuits and government enforcement actions:

- BK v. Tenet Healthcare Corp., where plaintiffs brought class action claims in both California and Florida alleging the company violated various privacy laws, by, among other things, subjecting users to "wiretaps without their knowledge, authorization, or "consent" through the use of Meta Pixel.
- R.S. v. Costco, where plaintiffs brought a class action alleging Costco Pharmacy engaged in deceptive and unfair trade practices by claiming it would protect consumers' privacy but then sharing personal health information in violation of HIPAA, the Washington Privacy Act, the Washington Cybercrime Act, and the Washington Uniform Health Care Information Act.
- *Price v. Carnival Corp.*, where plaintiffs brought class action alleging cruise line violated the Federal Wiretap Act and the California Invasion of Privacy Act by effectively "eavesdropping" on

- them by using Microsoft's Clarity tool to track mouse clicks, keystrokes and text entry on its website—without their consent.
- Waller v. Tampa Bay Times, where the plaintiff alleged use of Meta Pixel to track personally identifiable information and video watching history on the newspaper's website violated the Video Privacy Protection Act—a 1980s era federal law enacted to protect movie watching privacy of renters of videos from brick and mortar companies like Blockbuster. (VPPA claims are regularly brought alongside other consumer protection claims such).
- *United States v. GoodR*x, where the Federal Trade Commission sued the digital health platform for failing to notify consumers of unauthorized disclosure of health information. One infraction included sharing data with Meta to target GoodRx's own users with personalized health-and medication-specific advertisements on Facebook and Instagram.

Violations of these laws can result in severe consequences, including class action lawsuits and regulatory enforcement actions, civil penalties, statutory damages, and punitive damages. In evaluating whether the use of pixels is appropriate for your company or client, consider the following:

- 1. What third party analytics tools are we using to track website use?
- 2. Where are the pixels located, and what data are they collecting?
- 3. How are we storing and/or sharing data with third parties?
- 4. What industry-specific laws apply to us? (such as HIPAA, FERPA, GLBA, and law governing advertising to children)?
- 5. What state laws apply to us? (like the Florida Digital Bill of Rights and the California Privacy Rights Act)?
- 6. Are we living up to the promises and standards set out in our website privacy policy and terms of use?
- 7. Are we getting proper consent from our website visitors and customers to collect and use their data, and do those consents match up to what we are doing?
- 8.Do we need to consult with an attorney to understand our legal obligations and to draft privacy disclosures, obtain proper consents, or otherwise avoid risky practices that are fueling litigation and government enforcement actions?



MARCH CLE: MAKING A DIFFERENCE PRO BONO OPPORTUNITIES WITH GAL

The Statewide Guardian ad Litem Office ("GAL") represents Florida's children involved in the foster care system. GAL focuses on the legal and social interests of the child. GAL's best practices multi-disciplinary teams consist of a Guardian ad Litem attorney, a child welfare professional, and ideally, a trained volunteer or *pro bono* attorney from the child's community. This team provides the judge with the information needed and what the child wants for the court to decide what is in the child's best interests.

Not only does GAL help children in legal proceedings, but the team provides support outside of court, such as family visitations, educational support, and the child's medical and mental health needs.

Sara Urban is the Statewide Director of Recruitment for GAL. She presented a free CLE at the First District Court of Appeal, educating attendees on the ways GAL represents children in court and in the community on March 28, 2024.

There are multiple ways to make a difference in a child's life through GAL. "Volunteer Advocates" represent children in various types of proceedings. "Independent Living Attorneys" represent older dependent youth as co-counsel in dependency proceedings. The FAWL in love with GAL program is a partnership with Florida Association of Women Lawyers which pairs probono attorneys as mentors to youths as they transition to independence. Finally, pro bono attorneys can work alongside the GAL appellate team as part of the "Defending Best Interests" program by helping write appellate briefs. GAL offers training and continuing legal education (CLE).



The Catherine Chapman *Pro Bono* Service Award recognizes a member of the Florida Bar who embodies the enduring commitment to *pro bono* legal services and community involvement Ms. Chapman (TWL President 2015-2016) demonstrated during her lifetime.

Bridget Smitha is a Shareholder in the Tallahassee office of Stearns Weaver Miller. Her around-the-clock practice focuses on corporate defense, complex commercial litigation, and election law. She is ranked in The Best Lawyers in America, but it is not her professional excellence that makes Bridget deserving of the Catherine Chapman *Pro Bono* Service Award, rather it is her unwavering commitment to her community and ideals that make her the ideal recipient of this honor. Her many contributions have meaningfully touched the lives of many.

For more than 13 years, Bridget has been a member of the Florida Guardian ad Litem ("GAL") program which represents abused, neglected and abandoned children in court and the community. She has provided *pro bono* legal services for more than 10 children during these critical, often traumatic, times in their lives. Bridget's experience in family law – which she continues to practice *pro bono* on the basis of referrals to people in need – showed her the tremendous toll family conflict places on the children involved. She wanted the children to have, and to know they had, an unbiased champion advocating for their best interests. When she joined the program, she had two

young sons and understood the impact a caring and consistent adult can make in a child's life. While many shy away from the potential emotional struggles of working with the GAL program, Bridget said it was the challenge and the heartbreak that fueled her commitment. "I thought to myself, 'You know, these are issues that the children are dealing with on a daily basis. They're having to live with it every day of their life, so why can't I give up an hour or two of my time to help these children and hopefully maybe make their lives a little bit better?" she said in an interview promoting GAL.

In addition to her work with GAL, Bridget has assisted dozens of indigent individuals in *pro bono* matters relating to divorce, child custody, elder care, legal name change, employment termination, criminal, and garnishment challenges. Bridget is also active in the Tallahassee community. She served on Tallahassee Women Lawyers' Board of Directors from 2020-2021 and remains a member of the organization. She is a member of the Greater Tallahassee Chamber of Commerce's Leadership Tallahassee Class XXXIII. Bridget is committed to giving our community's most vulnerable members a voice, and in helping them find their own. Her skills and passion for serving inspires positive change in our community and in those who have the pleasure of knowing her.

SUGAR COOKIES

Ingredients

- 1 cup sugar
- 1 cup butter, softened
- 1 tsp. vanilla
- 1/4 tsp. salt
- 1 egg
- 2 cup flour
- 1/2 tsp. baking soda

Directions:

- Cream butter and sugar.
- Add vanilla, salt, and egg, then mix.
- Add flour and baking soda mixture and mix well.
- Roll dough into small balls in palm of hands.
- Flatten with the bottom of a glass.
- Bake on cookie sheet for 10-12 minutes at 350F.



SNICKERDOODLE BARS

Ingredients

- 2 1/3 cups all-purpose flour
- 11/4 tsp. baking powder
- 1/2 tsp. salt
- 3/4 cup butter or margarine, softened
- 11/4 cups granulated sugar
- 1/2 cup packed brown sugar
- 3 eggs
- 1 tsp. vanilla extract

Cinnamon Filling:

- 1 tsp. granulated sugar
- 1 tbsp. cinnamon

Glaze:

- 1 cup powdered sugar
- 1-2 tbsp. milk
- 1/4 tsp. vanilla extract

Directions:


- Heat oven to 350F. Spray or grease bottom only of al3x9-inch baking pan with cooking spray. In a small bowl, combine flour, baking powder, and salt; set aside.
- In large bowl, beat butter with electric mixer on high speed until creamy. Beat in sugars.
- Gradually beat in eggs and vanilla into sugar mixture until combined. On low speed, beat in dry ingredients until combined.
- Spoon half of the batter into a pan; spread evenly. Springle cinnamon-sugar mixture evenly over batter.
- Dollop teaspoon size amounts of remaining batter evenly over cinnamon sugar mixture
- Bakes 20 to 25 minutes or until golden brown and a toothpick inserted in the center comes out clean. Cool completely, about 1 hour.
- In a small bowl, stir glaze until smooth and thin enough to drizzle. Drizzle over bars

MEMBERSHIP DUES UPDATE

During the 2023-2024 year, total TWL membership dues are \$95 for lawyer members (\$45 going to FAWL and \$50 going to TWL) and has not changed in over eight years. The Florida Association for Women Lawyers (FAWL) sought chapter comments and input throughout the year, and as a result, FAWL voted to increase its dues an additional \$15 starting July 1, 2024. In addition, TWL dues will also increase its annual dues by \$15. Accordingly, beginning July 1, 2024, annual dues for TWL lawyer members will be \$125 (\$60 going to FAWL and \$65 going to TWL). TWL has also recently adopted a tiered structure for dues in its By Laws, which provides a discount to members of the judiciary and attorneys of governmental or non-profit organizations. Such members' dues will be discounted to \$110.

The increased membership dues take effect on July 1, 2024, so current members are encouraged to renew now at the current membership dues price!
